- WINDFALL ACT – passed!: 1 year back-pay for social security; the regular monthly amount
- PFP – raise not until January

- The Postal Headquarters Bldg., is trying to get building rented. A challenging task but agreed to take out walls in 2018

- 2<sup>nd</sup> Floor empty
- Open House was held in the building for realtors
- 3<sup>rd</sup> Floor – 11K a month (revenue)
- Surfside Post Office closed.
  - Shares space with Normandy Post Office (33154)
    - Suggest to write your Congressman (33141) or give them a call regarding the closure of the post office
- Hollywood parking lease not renewed for carriers to park. Current cost \$40.00/week
