Legislative Report:

Postal headquarters has offered to continue with PFP and paying 72% of Health Benefits. They are saying NO to adding an additional 40 hours of annual leave or 40 hours of leave to cash out. They want that to stand as it is.

The lawsuit is pending; however, it is very positive that the Court of Appeals has sided with NAPS and not postal headquarters.

Open season may be impacted; however, NAPS headquarters is on the Hill discussing this issue with congressmen and senators. Since we are experiencing a government shutdown, who knows what will transpire. It is so very important to build relationships with our congressmen and senators.
